Office Order

This has reference to the order dated 22nd March, 2021 and total four notifications related to the Schedule of Port Charges issued on 08th March, 2019 vide notification number:

- 1.) PT/2019/1/WKS/102016/G-396/GH1
- 2.) PT/2019/2/WKS/102016/G-396/GH1
- 3.) PT/2019/3/WKS/102016/G-396/GH-1
- 4.) GMB/T/SOPC/12(25)/2019/262

In above connection, it is to inform that as per the amendment made in the point no 14 of GENERAL TERMS & CONDITIONS and notification issued on 10th June, 2020 that the wholesale price index (WPI) escalation would be done with effect from 1st May every financial year instead of 1st April.

In this regard, the Reserve Bank of India has released the WPI data for the financial year 2020-2021 on 16th April, 2021 (<https://www.rbi.org.in/scripts/WSSView.aspx?Id=24476>). As per the data, the WPI for the financial year 2020-2021 comes to 7.40%. Accordingly the rates mentioned in above notification are escalated by 7.40% of the notified rate with effect from 1st May, 2021. Further the revised rate document is enclosed herewith for ready reference and implementation.

In view of above, your office is instructed to implement the escalated/increased rate with effect from the 1st May, 2021 and also inform the same to all port users at your level under your jurisdiction.

The above is issued as per the terms and conditions of the notification dated 10th June, 2020.
